Anticipated Replacement Improvements: The general description of the nature of the improvements included in the agreement is as follows:

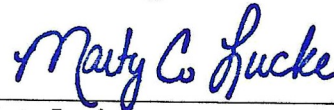
Applicant anticipates replacing all 100 wind turbines with new nacelles and rotors (blades).

Estimated Cost of the Anticipated Replacement Improvements: The estimated cost of the Anticipated Replacement Improvements being contemplated to be built by Applicant in the County is approximately \$230,000,000.

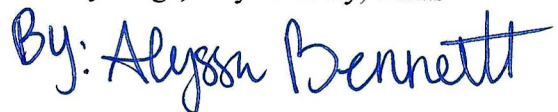

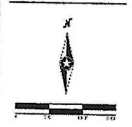

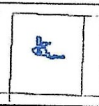
