
ORDER SETTING TAX RATE

The Floyd County Commissioners Court has adopted a 2022 property tax rate of \$0.656/\$100 valuation.


This tax rate will raise more taxes for maintenance and operations than last year's tax rate.

The tax rate will effectively be raised by 3.4 percent above the "No New Revenue Tax Rate" and will raise taxes for maintenance and operations on a \$100,000 home by approximately \$21.85.

THEREFORE, the 2022 tax rate for Floyd County shall be \$0.656/\$100 valuation. ORDERED this 6th day of September, 2022.
